



Dreamstreet Lending Pty Ltd: Home loan repayments for 1 year

GENERAL

1. The promoter of this "Home loan repayments for 1 year" promotion ("Promotion") is Dreamstreet Lending Pty Ltd ACN 124 009 785 ("Dreamstreet") of 179 High Street, Northcote VIC 3070 Australian Credit Licence Number 390024.

Melbourne United is an advertising and promotional partner of the Promotion only. Melbourne United is not the promoter, sponsor or administrator of the Promotion and is not responsible for the operation, administration or conduct of the Promotion, including the selection or determination of the winner. Melbourne United has no involvement in, and accepts no responsibility for, the prize, the awarding of the prize or any decision relating to the winner. All enquiries, claims or complaints relating to the Promotion or the prize should be directed to Dreamstreet.

2. The Promotion commences at 12:01am (AEST) on 1 June 2026 and closes at 5:00pm (AEST) on 30 November, 2026. ("Promotion Period").
 - a) Any person who participates in this Promotion acknowledges it is made subject to these terms and conditions and any person who participates in this Promotion is deemed to have accepted these terms and conditions.
 - b) This promotion is a game of chance.

WHO CAN ENTER?

3. To enter this Promotion, eligible entrants must, within the Promotion Period, submit an Application with Dreamstreet for an Eligible Loan in accordance with these terms and conditions.

An "Eligible Loan" is:-

- (i) owner-occupied homes, 'Principal & Interest' and/or 'Interest Only' homes loans; and
- (ii) for investment homes, 'Principal & Interest' and/or 'Interest Only' home loans.

4. The maximum number of entries in this Promotion is one for each Eligible Loan.
5. A person who makes a home loan application with Dreamstreet ("Application") will be eligible for this Promotion if:
 - a) the Application is made by a person who:
 - (i) is an Australian citizen;
 - (ii) is a permanent resident in the State of Victoria;
 - (iii) is not an employee (or immediate family member of such employee) of Dreamstreet, or any related corporation or agency associated with the Promotion;
 - (iv) is over the age of 18 years;



- (vi) has their Application approved by the lender on or before 5.00pm on 30 November, 2026 and the Eligible Loan settled and fully drawn down on or before 5.00pm on 21 December, 2026; and
- (vii) in Dreamstreet's opinion, satisfies the prime lending criteria.
An immediate family member means spouse, ex-spouse, de-facto spouse, child or step-child, parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.
- b) the Application relates to an Eligible Loan.
- c) the amount of new lending advanced is not more than \$2,000,000 in aggregate.
- d) The person is one of the first 100 persons who satisfies all the requirements set out in clause 5(a) to 5(c) (both inclusive) of these terms and conditions

DRAWING OF ENTRIES

- 6. The winning entrant will be drawn randomly at 179 High Street, Northcote VIC 3070 on 21 December 2026 at 5:30pm (AEST). The winner will be the first valid entry drawn.
- 7. If the prize has not been claimed within 30 days, an unclaimed prize draw will take place at the same time and place as the original draw, subject to any directions from a regulatory authority. The winner, if any, will be the first valid entry drawn

PRIZE

- 8. The total number of prizes to be won in this Promotion is one.
- 9. The winner will be reimbursed for the minimum loan repayment amount of an interest only repayment loan or principal and interest repayment loan (as the case may be) ('Minimum Repayment Amount') that is payable on the outstanding balance of their Eligible Loan pursuant to an eligible Application, after taking into account any amounts in any offset sub-accounts, **for a period of 1 year from the draw date**. For the avoidance of doubt, the Minimum Repayment Amount does not include any default interest that accrues on the principal loan as a result of the winning entrant defaulting on their payment obligations under the relevant loan agreement arranged by Dreamstreet.

PAYMENT OF MINIMUM REPAYMENT AMOUNT

- 11. Subject to the terms and conditions of this Promotion and the terms and conditions of the relevant loan agreement for the Eligible Loan, the first reimbursement of the Minimum Repayment Amount will occur within 28 days of the winning entrant's name being drawn. The reimbursement of the Minimum Repayment Amount due is conditional on the winning entrant making each relevant repayment towards the Eligible Loan (being interest only or principal and interest, as the case may be) to the lender of the Eligible Loan or at the direction of Dreamstreet.

If Dreamstreet determines that a correct loan repayment has been made in accordance with the applicable loan agreement for the Eligible Loan, Dreamstreet will reimburse the applicable Minimum Loan Repayment component of the loan repayment by way of payment to the loan account in respect of the Eligible Loan. For the avoidance of doubt, reimbursement of the Minimum Loan Repayment will be



calculated from the date of the draw, not the settlement of the Eligible Loan, **and so the Minimum Loan Repayment will be for the period of 1 year commencing on the date of the draw and ceasing on the expiration of such 1 year period.** Further, any amount paid or accrued but not yet paid by the winning entrant prior to their name being drawn as a winner in this Promotion will not be reimbursed.

FURTHER TERMS AND CONDITIONS

29. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, Dreamstreet (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Dreamstreet's control); (b) any theft, unauthorized access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by Dreamstreet) due to any reason beyond the reasonable control of Dreamstreet; (d) any variation in prize value to that stated in these terms and conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of the prize.
